A. Engineer for easements/retention ponds: There was another assessment done by TW Brown with the City finding. The cost would be approx. \$106,433.00. This does not include the installation for Water meter.

- B. There was a Motion made by Elizabeth for a onetime Assessment for All homeowner of \$2500.00 to cover the repairs to the easements/retention ponds, was Second by Viveca, all was in favor.
- C. There was a Motion made by Vickey and Second by Elizabeth all was in favor to apply for HOA Loan from Truist Bank to cover the initial cost of the repairs allowing the homeowners to pay the assessment in monthly installments. Due to Covid the cost of everything is going up and the BOD reserved the right to revisit the total agreed for the Special Assessment.
- D. Schedule a Special Meeting with all homeowner to keep them informed of Plan of Action for the easements /Retention Pond.
- E. BOD made the decision on homeowner ARC request to partially approve the request. The fines will remain as is. Homeowner will be notified by certified letter of the BOD decision.
- F. Violation Letters which have incur a fee will be sent Certified to homeowner
